By virtue of Clause 37 of the Ministerial Regulation Prescribing the Standards on the Administration and Management of Occupational Safety, Health, and Environment B.E. 2549 (A.D.2006), the Director-General of the Department of Labour Protection and Welfare issues the Announcement as follows:

Clause 1 This Announcement shall be called the “Announcement of the Department of Labour Protection and Welfare on Format of Performance Report of the Occupational Safety Officers in Advanced Technical and Professional Levels”

Clause 2 This Announcement shall come into force on and from the date of the announcement.

Clause 3 The performance report of safety officers in advanced technical level which is submitted



by the employer to the Director-General or to his assignee, as prescribed in Clause 37 of the Ministerial Regulation Prescribing the Standards for Administration and Management of Occupational Safety, Health, and Environment B.E. 2549 (A.D.2006) shall apply Form Jor Por. (Thor) as attached to this Announcement.

Clause 4 The performance report of the occupational safety officer in professional level which is submitted by the employer to the Director-General or to his assignee, as prescribed in Clause 37 of the Ministerial Regulations Prescribing the Standards for Administration and Management of Occupational Safety, Health and Environment B.E. 2549 (A.D. 2006) shall apply Form Jor Por. (Whor) as attached to this Announcement.

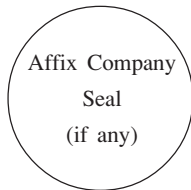
